## **SEASON LONG RENTAL INFORMATION:**

Groups can rent a time slot/court for the full paddle season, October 29, 2018 – March 29, 2019.

Groups interested in renting a court for the full season should submit the form found below by October 5. Slots will be awarded using a lottery system on October 9.

(MAXIMUM 2 COURTS PER REQUEST) **ONLY ONE REQUEST PER GROUP WILL BE INCLUDED IN THE LOTTERY. PLEASE LIST THE MEMBERS OF THE GROUP ON THE FORM.** Those given a slot have one week from notification to pay the full amount to reserve their slot. The court fee reserves the court for the whole season, Monday, October 29, 2018 – Friday, March 29, 2019.

SEASON LONG RENTAL: DAYTIME - 1 ½ HOUR TIME SLOTS- \$380/PER COURT  
EVENING (AFTER 5:00pm) - 1 HOUR TIME SLOTS - \$540/PER COURT

## **SIMSBURY FARMS PADDLE COURTS:**

We attempt to make the courts open as much as possible during light inclement weather. Obviously despite our best efforts there will be times that the weather is too severe or not practical for the courts to be open. Please read the court policy listed below.

1. Snow Removal – Simsbury Farms snow removal schedule places the highest priority on public right-of-ways (parking lots, sidewalks and roads). The maintenance staff will remove the snow off the paddle courts after those areas are cleared.
2. Simsbury Farms staff will turn on the court heaters to dry wet courts during or after light rain or snow, remove frost, or in some light inclement weather prevent snow/ice buildup. In some situations, groups may have to turn the heaters on themselves. If conditions exist that you need to turn the heaters on, please do not turn them on for more than thirty minutes prior to your court time.

NEW UPDATE: WHEN TURNING ON THE HEATER, PLEASE DO NOT TURN THE DIAL ALL THE WAY TO THE RIGHT. THIS CAN CAUSE THE TIMER TO LOCK AND THE HEATER WILL NOT TIME OUT AND SHUT OFF.

Please help us keep court costs down – heaters are not to be used to provide heat.

3. Simsbury Farms may choose to not turn on the heaters or close the courts if the weather forecast is for moderate or heavy snow, rain or sleet.
4. Cancellation information will be updated as best as possible on our website [simsburyrec.com](http://simsburyrec.com). Due to unexpected winter weather, there may be times that the courts may be closed before announcements can be made or after front desk hours.
5. If the courts are closed due to inclement weather, the first four dates affected will be rescheduled for April. Any additional rental times lost due to the courts being closed can be made up by contacting Simsbury Farms Front Desk. You must contact Simsbury Farms to reschedule. Rescheduled dates are only issued for times that the courts are closed due to inclement weather.
