## SUMMER 2024 DEPOSIT, PAYMENT PLAN, REFUND/CANCELLATION INFORMATION

## FOR CAMP STUFF-TA-DOO AND AWESOME ADVENTURE CAMPS

We are pleased to be able to offer our summer day camp families some flexible payments for the 2024 Summer.

Registration for Camp Stuff-Ta-Doo and Awesome Adventure Programs will begin on Tuesday, January 16, 2024 at 6:00 AM online at <u>www.SimsburyRec.com</u>.

**Deposits:** If you choose not to pay the registration fee in full at the time of registration, families registering their children for Camp Stuff-Ta-Doo (kids entering grades 1-6 in Fall '24) will be required to pay at least a \$100 deposit per child per week of camp that is signed up for and to also agree to a payment plan for the balance of the fees due. Families signing up their children for Awesome Adventure (kids entering grade 6-9 in Fall '24) will be required to pay at least a \$200 deposit per child, per week of camp being signed up for and to also agree to a payment plan for the balance of the fees due. Deposit options are only available for the Camp Stuff-Ta-Doo and Awesome Adventure Camp programs.

**Payment Plans:** If you have chosen not to pay the full balance due at the time of registration for Camp Stuff-Ta-Doo or Awesome Adventure, you can choose to enter into a payment plan with us that is designed to pay the balance of each session off in 3 payments. <u>Payment plans are only available for the Camp Stuff-Ta-Doo and Awesome</u> <u>Adventure Camp programs.</u>

If you make the minimum deposit of \$100 for a week of **Camp Stuff-Ta-Doo**, payments will be automatically charged to the credit card number that you used for the initial deposit, in the following manner:

**February 1 \$50, March 1 \$50, April 1 \$45**. If you choose to do the minimum deposit for multiple weeks of camp, please multiply the above monthly payments by the number of weeks you are signing up for.

If you make the minimum deposit of \$200 for a week **Awesome Adventure**, payments will be automatically charged to the credit card number that you used for the initial deposit, in the following manner:

**February 1 \$50, March 1 \$50, April 1 \$50**. If you choose to do the minimum deposit for multiple weeks of camp, please multiply the above monthly payments by the number of weeks you are signing up for.

You will receive an emailed receipt outlining the payment plan at time of registration and you will receive emailed receipts for each of the monthly payments charged to the payment card on file.

There will not be a payment plan option available other than these options. You can make payments to your account at any time that will lower the amount of the remaining payments. Your credit card will not be charged after the balance is paid in full.

**Credit Card Security**: Should you, as our customer, opt to allow credit card(s) info to be stored for use in payment plans or a future method of preferred payment, we understand the paramount importance of security in handling sensitive card information. Rest assured, our approach prioritizes the highest standards of security. By leveraging the secure infrastructure of <u>Authorize.net</u>, your stored cards remain protected within their robust systems. Our system accesses only the necessary data for payment transactions, ensuring the utmost security without compromising any

sensitive information within our own environment. The card data is never stored in the <u>SimsburyRec.com</u> software for security reasons. Most importantly, <u>SimsburyRec.com</u> neither reads nor displays the full credit card information, except for the last four digits and does not store the information in our servers. At no time will any of our staff have access to read stored credit card information.

**Refund/Cancelation Policy for Camp Stuff-Ta-Doo and Awesome Adventure Day Camps**: Please carefully review the refund/cancelation policy for these programs only.

Prior to March 31, 2024 – Full refunds for day camps will be granted for any reason, less a \$10 processing fee April 1, 2024-April 30, 2024 – Refunds for day camps will be granted for any reason less a \$100 non-refundable fee (unless a Dr. Note is provided)

Beginning May 1, 2024 – No refunds for day camps will be granted unless a Dr. note is provided.
